

## VAAMentoring - YOUR career options in microbiology

VAAM mentoring is meant to accompany a young scientist on a defined stage of his/ her career path and to advise him/ her on the many professional opportunities and perspectives within and outside of academic research. A decisive advantage of the VAAM as a microbiological society is the broad professional experience of its members in academic and industrial research, public administration and/or consulting, among others. This subject specific orientation of the VAAM mentoring programme is a special feature. The 1:1 assignment of mentees and mentors also ensures an intensive support. 1-2 meetings per year are planned, one of which will take place at the VAAM annual conference.

## Goals of VAAMentoring:

- Identifying the competences and skills of the mentees (personality development)
- Defining the specific interests, goals and skills of the mentees
- Advising on the development of career paths and strategies for this purpose
- Career/interest/direction-related shaping of the academic path
